In connection with your application for appointment as aviation cadet in the U. S. Army Air Corps, this is to remind you that the next educational examination will be held at Ellington Field, Texas, on November 12, 13 and 14, 1941.


Owing to the number of applicants to be examined physically prior to the written mental examination, it is requested that you report to the Station Hospital at Ellington Field at 7:30 A. M. on October 10, 1941 for the purpose of taking your physical examination. Bring the attached request for "64 examination" with you.

As the standards of the physical examination for flying are exceptionally high, it is essential that you report here for examination in the best possible physical condition. To that end it is recommended: a. That you so time your departure from home as to permit you to have a good rest - at least eight hours in bed on the night preceding the examination. b. That you avoid any undue eye strain, such as long auto drives by night, for several days preceding the examination. c. That on the morning of the examination you partake only of a light breakfast and avoid any undue exertion. d. That in all other particulars you bear in mind the exacting requirements of the physical examination for flying and exert a special effort to avoid all excesses, in order that you may appear before the examining Board in the best possible physical condition. e. Be sure to bring colored glasses.

You are advised that all expenses in connection with this examination must be borne by the candidate.
