RULES
of
THE
" MERVILLE "SOCIAL CLUB



**Annual General Meeting
July 17th 1943.**

Rule 19 is Amended and the following Rule is substituted:—

A Member may bring a Visitor to the Club. He is responsible for the Conduct and Integrity of the Visitor while on the Club premises, and that the Visitor makes no attempt to purchase any commodities whatsoever whilst on the Club premises. All Visitors must be signed on in the Visitor's Book. Full name and address and Member's name, (Not Initials). The Secretary has the right to refuse admission to Visitors without stating reasons.

1. That this Club be called THE "MERVILLE" SOCIAL CLUB, Exeter Road, Bournemouth.

Objects

2. The objects of the Club are to afford social amenities and recreation for its members.
3. To purchase, hire or otherwise acquire for the Club any property, utensils, furniture, games, newspapers, necessary for the proper organisation of the Club.
4. To purchase and supply to its members wines, spirits, malt liquors, tobacco, provisions and other articles usually provided and supplied at Clubs.

Executive

5. A Committee consisting of a President, Chairman, Treasurer, Secretary and 8 members shall be elected, and charged with the government and control of the

Club, any member may be elected as a Vice-President, but such Vice-Presidents together with the Secretary shall not have power to vote on Club matters.

Election of Members

6. Every person seeking membership shall be of the age of 18 years and upwards and shall be proposed by one member and seconded by another, and his or her name and address shall be posted on the notice board 7 days before being brought under the consideration of the Committee, who alone shall have power to elect members.

Members of His Majesty's Forces and Fire Brigade Services, and Temporary Members not living in the Town of Bournemouth to be admitted to Membership after being posted 48 hours on the Notice Board.

Subscriptions

7. Subscription payable by Members shall be 21/- per annum to be paid yearly or half-yearly. Members of H.M. Forces and Fire Services shall pay a subscription of 10/6, and will remain Members for the duration of the War. Temporary Members subscription to be 2/- for one month. The number of Temporary Members will be limited.

Members' Conduct

8. The Committee shall have the right to suspend or expel any member of the Club for misconduct, but in every case the offending member shall have the right to appear before the Committee and state his case, and if the member is dissatisfied with the Committee's decision he or she has the right of appeal, such appeal to be in the Secretary's hands within 7 days of the Committee's findings.

9. Every member already elected and every future member shall be absolutely bound to conform to the Rules and Regulations of the Club and to all Byelaws made from time to time by the Committee who shall have power to make such Byelaws to meet contingencies that may arise.

10. No book, newspaper or other article shall be moved from the Club premises. Any damage caused by a member shall be made good by him to the satisfaction of the Committee.

11. No gambling or betting shall be allowed in the Club under any pretence whatever.

12. The Club shall be open from 10.30 a.m. to 2.30 p.m. and 6 p.m. to 11 p.m.

13. The hours permitted for the supply of intoxicants shall be:—
Week days, 10.30 a.m. to 2.30 p.m.
and 6 p.m. to 10 p.m. (Summer

time 10.30 p.m.), Sundays, Christmas Day and Good Friday, noon to 2 p.m. and 7 p.m. to 10 p.m.

14. The Treasurer shall be responsible for all monies received from the Secretary and all other sources appertaining to the Club.

15. Payment of accounts are to be made monthly by cheque, signed by Treasurer and Secretary.

16. Duly audited accounts shall be prepared by the Secretary and presented at the Annual General Meeting.

17. Any member failing to pay his or her subscription when due shall cease their membership within 14 days after being notified by the Secretary that subscription is due.

18. No rule shall be altered except by a General Meeting of members.

19. Members are not allowed to bring visitors in the Club.
