Pursuant to auth contained in Ltr, Hq ASC, US Strategic Air Force's in Europe, 10 July 1944, sub: "Return of Combat Crews for Assignment within the US", Sec V, Cir 127, WD, 29 May 1943, VOGC Eighth AF, and Ltr, AG 370.5 (10 Aug 1944) OB-S-SPMOT-MSub: "Procedure for Return of Individuals" dated 16 Aug 1944, the following AC O European T of Opns, having rpt to this Hq per competent auth for the purpose of ret to the Z of I, are reld fr asgmt to Casual Pool, this Hq, and WP by mil acft to a US airport, rpt on arrival to Debarkation O thereat for the purpose of reassignment. O concerned are reld fr atchat 152nd Replacement Co, 127th Replacement Battalion (AAF) AAF Sta 591.

Travel by rail, surface vessel, belligerent vessel a/o mil acft is atzd. Per diem of \$7.00 per day is atzd only while traveling by air on official business in accordance with existing laws and regulations. Reimbursement for grs not to exceed \$4.00 per day and \$1.25 per day for subs is atzd these O while in a travel status in accordance w/Cir 63, Hq European T of Opns, USA, 5 June 1944.

This is a permanent change of station.

Clothing and baggage to accompany an individual will not exceed 65 lbs.
